## TO ALL BUSINESS MANAGER OF THE IBEW

**Subject: Request for Cooperation Regarding IBEW Members Working in Quebec** 

Dear Brothers,

It has come to our attention that IBEW members—whether wiremen or linemen—are currently working in the Province of Quebec without having been properly dispatched from your Local Union to our Local Hall.

Based on our findings, it appears that some of these workers may have registered with the FTQ and are reporting to the FIPOE Local Union, rather than signing with the CPQMC-International and reporting to IBEW Local 568.

As you may know, in the Province of Quebec, construction workers must register with a union association before the **Commission de la Construction du Québec** (CCQ) will issue a work permit. If a worker signs with the FTQ, they are automatically affiliated with the FIPOE Local Union.

Moreover, Law 20 clearly states that dual association is prohibited—a construction worker cannot be affiliated with two different associations simultaneously.

In addition, the IBEW Constitution, under Article XXV – Misconduct, Offenses, and Penalties, Section 1(f), clearly stipulates:

"Working for or on behalf of any employer, employer-supported organization, or other union, or the representatives of any of the foregoing, whose position is adverse or detrimental to the IBEW" is considered misconduct.

Therefore, if any of your members are currently working for an employer in the Province of Quebec, they must be signed with **CPQMC-International** and report to our Local Hall. They are also required to present a **reference letter** and a **receipt confirming that their dues are paid up to date**. Failure to comply may result in penalties or charges brought before the Executive Board.







We respectfully request your cooperation and ask that you provide us with a list of members you believe may be working in Quebec. To verify their CCQ affiliation, we will need their **Social Insurance Numbers**.

Please be assured that our intent is to facilitate greater mobility of skilled labor across provincial borders in Canada. This initiative is essential to addressing the ongoing irregularities and inequalities between the FIPOE and the IBEW.
